

EARLY READING INTERVENTION

TEMPORARY FLEXIBILITY AND CTE RATIOS

Temporary Flexibility - The Appropriation Act provides the following temporary flexibility to the Standards of Quality notwithstanding any other provision in statute or in the Appropriation Act Direct Aid to Public Education Item:

- school divisions may elect to increase the teacher to pupil staffing ratios in kindergarten through grade 7 and English classes for grades 6 through twelve by one additional student;
- the teacher to pupil staffing ratio requirements for Elementary Resource teachers,
 Prevention, Intervention and Remediation, English as a Second Language, Gifted and
 Talented, Career and Technical funded programs (other than in Career and Technical courses where school divisions will have to maintain a maximum class size based on federal
 Occupational Safety & Health Administration safety requirements) are waived; and
- the instructional and support technology positions, librarians and guidance counselors staffing ratios for new hires are waived.

CTE Ratios - <u>8VAC20-120-150</u> of the Virginia Administrative Code specifies a required maximum class size of 20 students per laboratory for laboratory classes that use equipment identified by the U.S. Department of Labor for hazardous occupations. The career and technical education courses that have this restriction are published annually by the Virginia Department of Education.

INTERNET USE POLICIES

Acceptable Internet Use Policies - <u>Section 22.1-70.2</u>, Code of Virginia, requires each local school division to certify annually division-wide compliance with the following provisions:

Every two years, each local school board must review, amend if necessary, and approve the school division's acceptable use policy for the Internet. At a minimum, the policy must contain provisions that:

- (i) are designed to prohibit use by division employees and students of the division's computer equipment and communications services for sending, receiving, viewing, or downloading illegal material via the Internet;
- (ii) seek to prevent access by students to material that the school division deems to be harmful to juveniles as defined in Section 18.2-390;
- (iii) select a technology for the division's computers having Internet access to filter or block Internet access through such computers to child pornography as set out in Section 18.2-374.1:1 and obscenity as defined in Section 18.2-372;
- (iv) establish appropriate measures to be taken against persons who violate the policy; and (v) include a component on Internet safety for students that is integrated in a division's instructional program.

Each school division's policy must be posted on its website in accordance with Section 22.1-253.13:7.
