During the Spring 2023 SOL Non-Writing test administration, 10 students from Jenkins Elementary School were assigned an incorrect Grade 5 Science SOL test form. That is, they should have been assigned an audio form according to their LEP Assessment plans. This issue was discovered after testing began, which meant there would not be another test form available to these students once the alternate audio form was assigned. PWCS staff contacted the Virginia Department of Education (VDOE) about this issue when it was discovered, and the students were promptly assigned the alternate audio form. Two of those students passed what was essentially their first attempt and eight did not.

A review of the referent eight students suggests that their test performance was inconsistent to their performance in the class during the school year. Under normal circumstances, these students would be administered an expedited retake of the Grade 5 Science SOL test following targeted remediation, which did occur incidentally. However, due to the limited availability of test forms, these eight students were not given a fair opportunity to participate in an expedited retake. Consequently, PWCS believes these eight students should be removed from the calculation associated with *Academic Achievement – Science*. PWCS is aware that three of the eight students were already removed from the calculation due to an SOA EL adjustment or transfer adjustment.

Note: PWCS does not believe that this issue will occur frequently in the future because multiple test forms are usually available during "normal" test administrations. Regardless, the school's test coordinator for 2023-24 has been directed to share an updated plan for reviewing student status prior to assigning test forms.

VDOE Note: There were seven students that failed the assessment rather than eight, per a conversation with division staff.
