The Regulations Governing Special Education Programs for Students with Disabilities in Virginia provide the requirements for special education programs within the Commonwealth. Pursuant to Chapter 502 of the 2024 Acts of the Assembly, this action will amend 8VAC20-81-10 to include a definition for "short term objectives" and amend 8VAC20-81-110 to include parent and student input as required content in an IEP for all relevant students.

On July 25, 2024, the Board authorized the VDOE to proceed with the fast-track revision to the regulation.

Chapter 502 of the 2024 Acts of the Assembly directs the VDOE to amend its regulations to include a definition of "short term objectives" and to include parent and student input as required content in an IEP for all relevant students. However, the legislation did not include a definition of "short-term objectives," so the Board has approved one.

This regulatory action is expected to be noncontroversial because it is required to keep the regulation in line with changes in the law. The definition of "short-term objective" proposed by the Board is not expected to be controversial.
