CLOSED SESSION

The Board convened on Thursday, June 20, 2024, at 9:00 a.m., for the purpose of considering disciplinary cases related to teacher licensure. B. First and Final Review of College Partnership Laboratory School Fiscal Agent and Partnerships

Mr. Hansen moved that the Board approve the application of Old Dominion University to serve as the fiscal agent and partner for the Future Educator's Academy and that the VDOE require Germanna Community College to resubmit its college partnership laboratory school contract for amendment and that the President of the Board and Superintendent of Public Instruction be authorized to negotiate and execute an amendment to the Future Educator's Academy contract consistent with this action. The motion was seconded and carried unanimously.

Mr. Hansen moved that the Board approve the application of Old Dominion University to serve as the fiscal agent and partner for the MG Tech Lab School and that the VDOE require Mountain Gateway Community College to resubmit its college partnership laboratory school contract for amendment and that the President and Superintendent be authorized to negotiate and execute an amendment to the MG Tech Lab School contract consistent with this action. The motion was seconded and carried unanimously.

Mr. Hansen moved that the Board approve the application of Old Dominion University to serve as the fiscal agent and partner for the Isle Maritime Trades Academy and that the VDOE require Paul D. Camp Community College to resubmit its college partnership laboratory school contract for amendment and that the President and Superintendent be authorized to negotiate and execute an amendment to the Isle Maritime Trades Academy contract consistent with this action. The motion was seconded and carried unanimously.

Mr. Hansen moved that the Board approve the application of Old Dominion University to serve as the fiscal agent and partner for the Explore@RC Lab School and that the VDOE require Roanoke College to resubmit its college partnership laboratory school contract for amendment and that the President and Superintendent be authorized to negotiate and

execute an amendment to the Explore@RC Lab School contract consistent with this action. The motion was seconded and carried unanimously.

Mr. Hansen moved that the Board approve the application of Old Dominion University to serve as the fiscal agent and partner for the Southwest Virginia HEALS Lab School and that the VDOE require Emory and Henry College to resubmit its college partnership laboratory school contract for amendment and that the President and Superintendent be authorized to negotiate and execute an amendment to the Southwest Virginia HEALS Lab School contract consistent with this action. The motion was seconded and carried unanimously.

C. First and Final Review of College Partnership Laboratory School Application from Old Dominion University – Aerospace Academy of the Eastern Shore

Mr. Hansen moved to waive first review and approve the college partnership laboratory school application for Old Dominion University – Aerospace Academy of the Eastern Shore for five years with annual reviews, and to delegate to the President and Superintendent final negotiation and execution of the lab school contract. The motion was properly seconded and carried unanimously.

D. College Partnership Laboratory School Final Funding Decisions

Dr. Andy Armstrong, Assistant Superintendent of Strategic Innovation, presented this item to the Board. The material for this item can be found on <u>the Board's page on the VDOE</u> website.

Mr. Hansen moved to award start-up funds and up to \$3.36 million in per-pupil funding from the college partnership laboratory school fund in accordance with the Board's *Guidelines* and to delegate to the president and superintendent final negotiation and execution of the Old Dominion University STEM Academy at Booker T. Washington Elementary School lab school contract. The motion was properly seconded and carried unanimously.

Mr. Hansen moved to award start-up funds and up to \$1.8 million in per-pupil funding from the college partnership laboratory school fund in accordance with the Board's *Guidelines* and to delegate to the President and Superintendent final negotiation and execution of the

George Mason Data Science Computing and Applications lab school contract. The motion was properly seconded and carried unanimously with Ms. Holton recusing herself.

Mr. Hansen moved to award start-up funds and up to \$3 million in per-pupil funding from the college partnership laboratory school fund in accordance with the Board's *Guidelines* and to delegate to the President and Superintendent final negotiation and execution of the Old Dominion University Aerospace Academy of the Eastern Shore lab school contract. The motion was properly seconded and carried unanimously.

Mr. Hansen moved that the Board award to the lab schools being established by Germanna Community College, Mountain Gateway Community College, Paul D Camp Community College, Roanoke College, and Emory & Henry College additional start-up moneys from the College Partnership Laboratory School Fund, in addition to any accrued interest, for the sole purpose of supporting the partnership and start-up activities provided by Old Dominion University as Fiscal Agent and Partner in such relative amounts as are appropriate, taking into account the date proposed for opening the particular lab school, the relative expenses associated with travel to the various lab school locations, and total students expected to be served and that the President of the Board and Superintendent of Public Instruction be authorized to negotiate and execute amendments to the lab school contracts to accomplish this. The motion was properly seconded and carried unanimously.

E. Final Review of Computer Science Standards of Learning

Mr. Rotherham made a motion to approve the proposed 2024 Computer Science Standards of Learning to be fully instructionally implemented in 2025-2026 and authorize the VDOE to make any final clarifying and/or technical edits. The motion was properly seconded and carried unanimously.
