**CLOSED SESSION**

The Board convened on Thursday, July 24, 2024, at 9:00 a.m., for the purpose of considering disciplinary cases related to teacher licensure. President Creasey approved the remote participation of Mr. Bill Hansen under the Board Bylaws and § 2.2-3708.3(B)(1) of the Code of Virginia because he met the definition of a person with a disability as defined in § 51.5-40.1. Under state law, Mr. Hansen counted toward the quorum as if he was physically present.

Mrs. Kilgore made a motion to enter into a Closed Session in accordance with § 2.2-3711 and 2.2-3712 of the Code of Virginia, under the following enumerated subsection:

Subsection 40: Discussion or consideration by the Board of Education of information relating to the denial, suspension, or revocation of teacher licenses subject to the exclusion in subdivision 11 of § 2.2-3705.3.

And that legal counsel to the Virginia Board of Education, as well staff members, whose presence would aid in this matter, participate in the closed meeting. The motion was properly seconded and carried unanimously. The Board went into closed session at 9:00 am. Mrs. Kilgore made a motion that the Board reconvene in open session.


**DISCUSSION OF CURRENT ISSUES**
